

# TOWN OF WOODWAY

## ORDINANCE 18-595

AN ORDINANCE OF THE TOWN OF WOODWAY AMENDING THE BUDGET FOR THE FISCAL YEAR ENDING DECEMBER 31, 2018; PROVIDING FOR SEVERABILITY; ESTABLISHING AN EFFECTIVE DATE AND AUTHORIZING SUMMARY PUBLICATION BY ORDINANCE TITLE ONLY.

WHEREAS, the Town Council of the Town of Woodway wishes to make a second amendment to the Budget to allocate additional expenditure authority from certain funds in order to meet necessary expenditures of money not provided for in the annual budget and not reasonably foreseen at the time of filing the preliminary budget; and

WHEREAS, pursuant to RCW 35A.33.090 five days have elapsed after the introduction of this ordinance and any taxpayer appearing at the meeting which this ordinance is voted on has been given opportunity to be heard for or against the adoption thereof.

NOW, THEREFORE, the Town Council of the Town of Woodway does hereby ordain as follows:

Section 1. That the adopted expenditures for the 2018 budget are hereby amended as follows:
