TREE PERMIT APPLICATION SUPPLEMENT

This permit application is for the removal of tree(s) 8" in diameter and greater measured 4.5' above grade level and shall apply to the removal of trees associated with Routine Property Maintenance, Land Development Activities, and Emergency Removal as defined in WMC 16.12. This application shall be reviewed and approved by the Public Works Director pursuant to the provisions of WMC 16.12.

- The number of trees that may be removed for Routine Property Maintenance per 12-month period are listed on the next page and correspond to the zoning district in which the property is located.
- Hedge trees and trees removed as part of Land Development Activities or because they are a hazardous do not apply toward the maximum tree removal allowed in a 12-month period.


